#### **Minimum Background Requirements**

- 1. You must have a clean criminal background. No felonies.
- 2. No drivers license nor professional license suspensions within the last 10 years.
- 3. DUI acceptable if the disposition date is greater than 10 years.
- 4. No unpaid parking tickets and or no pending court cases.
- 1. Print the attached form. (Do not sign the form until you are in front of a notary).
- 2. Complete all information requirements on page 1 and the first half of page 2 and page 4. If not applicable put n/a.
- 3. Have the document notarized in the required areas.
- 4. Submit your background check forms **in person** to the following address, let them know at the front desk you are submitting forms for backgrounds.
