The employee chooses the treating provider unless the employer is self-insured. In the latter case, the employer/insurer may choose the provider except in emergencies.

Provider Lists

Provider lists and directories may be utilized. There is no state-mandated posting.

Managed Care Options

The use of managed care practices is permitted as long as they do not interfere with the employee's right to choose the treating provider in the case of employers who are not self insured.

Additional Regulation

Vocational rehabilitation is available to injured workers if they are unable to return to the preinjury type of employment after they are off work for 150 days. Worker participation is voluntary, with payment made from the IC's special fund.
